OPEN POSITIONS OF SECRETARY & TREASURER

Secretary duties include

- keep an accurate written account of the proceedings of the Association
- keep and read the Minutes of the previous meeting at each General Meeting or Board meeting.
- record the official results of all voting performed by or for the Association.

- correspond with others as directed by the President and/or Board of Directors
- "Making Our Little Corner of Mashpee Better"

Tresurer duties include

- collect the dues from all members and keep a record of such collection.
- receive and deposit annual dues and all other monies coming into the Association.
- pay out funds for expenses as approved by the Membership and as directed by the president;
- keep an up-to-date itemized account of receipts and expenditures, acceptable for auditing purposes.
- keep an up-to-date record of membership and dues paid.

- prepare written financial statements for each meeting of the board of directors.
- prepare the proposed annual budget for approval and/or amendment by the Board of Directors
- execute legal documents necessary to enforce the collection of annual dues, including notice of liens; and to issue statements of clear title, and statements of good standing.

ACTIONS BEING TAKEN BY THE TOWN TO ADDRESS SANTUIT POND WATER QUALITY


The Mashpee Enterprise ran an article on 9/8/2021 announcing that "a multipronged project to increase Santuit Pond's resilience to harmful algal blooms in a warmer and wetter climate has been awarded \$131,000 through the state's Municipal Vulnerability Preparedness program. The Santuit Pond project will leverage previous studies and more than a decade of water quality monitoring to develop designs for stormwater infrastructure to reduce nutrient pollution, review the town's bylaws to reduce nutrient impacts and establish a public education and outreach program."

The Board recently received (and shared on Facebook) a letter from the Mashpee Board of Health. In summary it states that all properties that are within 300 feet of Santuit Pond are ordered to have within 30 days:

- 1). Septic inspection
- 2). System pumped or evidence of pumping within the last 3 years

This is an attempt to reduce nitrogen in the soil that runs off into the pond.
